

### **FAR and DFARS Requirements**

The clauses in Section 52 of the FAR and the DFARS herein below set forth and in effect on the date of this Order are each incorporated herein by this reference and made a part of this Order. In all such clauses, the term "Contractor" shall mean "Seller," the term "Contract" shall mean this "Order," and the term "Government Contracting Officer" or equivalent phrases, shall mean "Buyer" as applicable; except when a right, act, authorization, or obligation can be granted or performed only by the Government or the prime contract Contracting Officer or duly authorized representative, for example in FAR 52.227-1 or FAR 52.227-2, or when title to property is to be transferred directly to the Government, in which case the term "Government" or "Contracting Officer" retains its literal meaning and is not to be construed as "Buyer." It is intended that the FAR and DFARS clauses as listed herein shall apply to Seller in such manner as is necessary to reflect the position of Seller as a subcontractor to Buyer, to ensure Seller's obligations to Buyer and to the Government, and to enable Buyer to meet its obligations under its Prime Contract or subcontract. Seller shall incorporate into each lower tier contract issued in support of this Order all applicable FAR provisions and clauses in accordance with the flow down requirements specified in such clause(s).

If any of the following standard clauses or any FAR/DFARS clauses contained herein do not apply to a particular Order due to the nature of the work performed (e.g., FAR 52.246-2 "Inspection of Supplies – Fixed Price" does not apply if the Order is solely for Services), or the products supplied (e.g., COTS items as defined by FAR 2.101) such clauses are considered not applicable to that Order. Any Seller asserting commerciality (COTS and/or Commercial Product or Commercial Service), must provide Buyer with a completed Commercial Product Determination form with Seller's proposal.

When the products or services furnished are for use in connection with a U.S. Government prime contract or subcontract, in addition to the General Purchase Order Terms and Conditions, the following clauses shall apply, as required by the terms of the prime contract, or by operation of law or regulation. The effective version of each Federal Acquisition Regulation (hereinafter "FAR") clause shall be the same version as that which appears in Buyer's prime contract (as amended) or higher tier subcontract (as amended) under which this Order is a subcontract.
